


Properties can be rented if they have an energy rating from A to E.

The graph shows this property's current and potential energy efficiency.

Properties are given a rating from A (most efficient) to G (least efficient).

Properties are also given a score. The higher this number, the lower your carbon dioxide (CO₂) emissions are likely to be.

The average energy rating and score for a property in England and Wales are D (60).

Breakdown of property's energy performance

Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO₂). The energy used for heating, lighting and power in homes produces over a quarter of the UK's CO₂ emissions.

In average household produces	6 tonnes of CO₂
In this property produces	1.9 tonnes of CO₂
In this property's potential production	1.8 tonnes of CO₂

By making the [recommended changes](#), you could reduce this property's CO₂ emissions by 0.1 tonnes per year. This will help to protect the environment.
